RESULT NOTICE

Sub: List of candidates selected to the 12 posts of Assistant (G/S&P/F&A) Gr. III on the basis of the performance in the written test and qualification of the typing test – Advt. No. Rectt./02/2015.

The laboratory had advertised 12 posts of Assistant (G / S&P / F&A) vide Advertisement No. Rectt./02/2015 where in the last date of submission of duly filled in application forms complete in all respects was 15.09.2015. A total of **5599** applications were received by the office for the three posts codes as follows:

* Out of above said posts, 01 (one) post is reserved for Persons with Disabilities (PwD) under “**Hearing Impaired**” category.

A total of **3449** candidates were found eligible by the Screening Committee to appear for the written test (First Phase of Recruitment) which was objective type and common for all the three cadres comprising of two parts i.e. Part – A (Language – English / Hindi) and Part – B (General Knowledge). A written test for **3449** applicants was conducted on 05.02.2017. A total of **1880 candidates** appeared for the written test and **1569** candidates were absent. The minimum cut-off marks in the written examination category-wise as decided by the Core Committee members and duly approved by the Director were fixed as follows:

On the basis of the above mentioned cut-off marks, a total of **101** candidates (i.e. **90 candidates in actual for the three posts codes as some of the candidates had applied for multiple posts and had cleared the written test for multiple posts**) qualified the written test. **06 (Six) candidates under the PwD category appeared for the written test. None of them qualified the written test.** A total of **90 candidates** were then called for Typing Test (Second Phase of Recruitment) conducted on 29.10.2017 which was of qualifying nature. A total of **67 candidates** appeared for the written test out of which **31 candidates** qualified the typing test for which the minimum qualifying speed for English and Hindi was as follows:
